Written objections not filed by the ordered date and time will not be considered. Written objections may be filed with the required filing fee one of three ways: 1) Mailed to Hennepin County District Court - Probate/Mental Health Division, 300 South Sixth Street - C4 Govt. Ctr., Minneapolis, MN 55487-0340; **or** 2) Electronically filed using the electronic filing system; **or** 3) Placed in the on-site drop box designated for court filings.

NOTICE IS ALSO GIVEN that (subject to Minnesota Statutes § 524.3-801) all creditors having claims against the Estate are required to present the claims to the Personal Representative or to the court within four months after the date of this Notice or the claims will be barred.
