CALL TO ORDER

The meeting was called to order at 9:15 a.m., a quorum being present.

Pursuant to Minnesota Statutes Section 13D.021, the meeting was held by electronic means and Council Members participated remotely due to the local public health emergency (novel coronavirus pandemic) declared on March 16, 2020.

The Presidential General Election for the City of Minneapolis was conducted on November 3, 2020, with final tabulation of questions on that ballot having been concluded on November 10, 2020. In total, 238,104 ballots were cast, representing an 81.3 percent turnout among registered voters. Unofficial results were posted to the City's elections website for public access. A full report, including a statistical analysis, has been compiled and provided to the Canvassing Board and published to the City's website.

Minnesota Statutes designate the City Council as the Canvassing Board for municipal elections. By convening the Canvassing Board on the tenth day following the general election, the City of Minneapolis is within the statutory timeframe to complete the canvassing of returns.

Ellison moved approval of the following Order which:

1. Certifies the official results of the 2020 General Election.

2. Declares the official results for Ballot Question No. 1 pertaining to Redistricting of Wards and Park Districts and Ballot Question No. 2 pertaining to Special Municipal Elections.

3. Directs the City Clerk to submit a certified copy of the official results of the 2020 General Election to the Hennepin County Auditor and to file and preserve the original returns and all election records for the 2020 General Election in accordance with Minnesota Election Law.
